## **REGISTRATION PHASES OF FLIGHT**

#### PREFLIGHT (1-30 days):

- Download IS-BAO document suite, tools, and guidance
- Web meeting with Aviation Manuals to tailor GCOM to appropriate regulatory framework, size, scope, and type of operation

#### ENGINE START (30-90 days):

- Meet with FS1 approved implementor to ensure:
  - IS-BAO implementation •
  - IS-BAO pre-audit gap analysis
  - IS-BAO chapter validations

#### TAKEOFF (90-180 days):

1-day audit by FS1 approved Auditor:

#### ENROUTE TO STAGE 2 (Registration-24 months):

- FS1 approved implementor to ensure:

    - IS-BAO adherence/updates
    - SMS operational proficiency
