Regulatory Update

The 8th ICAO Ground Handling Task Force (GHTF) takes place in Montreal, 5-7 March 2018. We will be participating in the meeting at which stage we expect to have the final draft of the guidance document for Ground Handling Service Providers (GHSPs) aimed at States, aerodromes, operators and GHSPs themselves.

Expected output is to have a working document available for presentation by the chair to the ICAO ADOP in Q2 2018, material to be available for States Q3 2018, and by Q4 2018 to consider development of SARPs/PANS. This also ties in with work on the SMP to look at extending the scope of SMS in aviation.

There is much more work to be done on this, not just at ICAO level but also at States level, particularly the EC. We need to invite regulators to each of the workshops to better understand the IS-BAHTM and its processes.



Accident Waiting to Happen – The importance of Effective Near Miss Reporting

Planning for Audits in Advance

The Audit Programme Manual (APM) revision issued in early 2017 brought notable change to the IS-BA Programmes. The requirement for auditors is to validate the effective implementation of the organisation's Remedial Action Plans (RAPs) related to the findings identified during the audit, prior to IBAC acceptance of the Audit Report, and subsequent issue of the organization's registration. <u>Read more HERE</u>.

As we move into 2018, IBAC will continue to work closely with the auditors to further standardize auditor's responses on the Audit Report Forms.

Changes to the IS-BAH Auditor Accreditation for 2018

To bring the IS-BAH and IS-BAO auditor accreditation processes into a closer alignment, IBAC is making some changes to the IS-BAH accreditation processes. These processes become effective July 1st, 2018 with the issuance of the IBAC International Standards for Business Aircraft Audit Programme Manual 6th Edition. This new APM combines the processes and procedures for the IS-BAO and IS-BAH programmes into one consolidated manual. While the accreditation processes are not completely aligned, they have been harmonized considerably. <u>Read more</u> <u>HERE.</u>
